# A NOTE FROM MARY

I recently read a post from someone who was upset about a song that is being used a lot in churches today. Their complaint was "This song doesn't even address God. It's a song to other Christians asking God to bless them." The part that got me, though, was the comment, "I mean, I know it's straight out of scripture, but it's not appropriate for worship." (!!) It took a lot of restraint not to argue that the Bible is full of scripture in which people encourage each other. And the book of Psalms, Israel's hymnbook, is full of songs directed toward God (from individuals and assembled believers), and toward fellow worshippers, encouraging them in their worship and their walk. Why? Because we need both. We need God, we need to be in deep relationship with Him, and we need each other. God created us to be in community with one another, to encourage one another, to speak his truths to one another.

When things are difficult, we need reminders of God's goodness. We need to be reminded of His love and presence when we are overwhelmed and unable to feel His presence. We need songs of testimony. We need scriptural songs to remind us of who He is and what He has already done for us. I am convinced Satan does and is doing all he can to divide God's people, and sometimes it is easy to fall for it. Yet we are called to love and to build bridges in everything we do. We are called to carry burdens for each other, to bless each other, and to serve each other, within our congregation and in our lives outside these walls.

## **Called Church Conference**

A Special Called Church Conference will be held on Wednesday, September 16, 2020 at 7:00 pm.

We are required to have 50 members present at a conference/business session in order to vote on and to enact business items. We did not have a quorum at our July 2020 quarterly conference, making this called conference necessary.

The purpose of the called conference is to address the following specific issues and concerns:

- 1. We are required to elect church officers and to approve certain committee positions at the July Conference. The Enlistment Committee Report presented at that regular church conference was not approved due to the lack of a quorum. We will vote to affirm the report as presented at the July Conference. No additional officers or positions will be considered at this time.
- 2. The Finance Committee and the Properties Committee will move that renovations be made to the picnic shelter to create an outdoor space under the carport. Updated lighting, ventilation and painting are required. Further improvements to the bathroom area would need to be revisited at a later date. The cost would be \$2,500 and the funds would come from Capital Improvements.
- 3. The Finance Committee and Properties Committee will move that one additional security camera be installed at the back of the Gym over the bus parking area. The cost would be \$1,000 and the funds would come from Capital Improvements.
- 4, The Finance Committee will move that a designated fund be established for the Carson Smith Scholarship Fund (moving it from the Memorials Fund).
- 5. The Deacons will present a proposal to address Remote Access to church conferences during this 2020-2021 pandemic period. A full description and explanation of the policy will be sent to the membership for consideration. In short, we are proposing a limited, short-term, temporary, emergency policy that will allow for members to attend the conference(s) remotely during this emergency time.

If a quorum of 50 members is not present on Wednesday, September 16, the called conference will be moved to Sunday, September 20. A vote, without discussion or debate, will be taken at each of the worship services on that date.

#### College Park Baptist Church Temporary, Emergency Policy Change to Allow Remote Conferences and Voting During 2020 Pandemic August 23, 2020

The College Park Baptist Church constitution has the following requirements for business conferences:

- A quorum of 50 or more church members must be physically present to allow for voting.
- · All voting must be done in person, except for deacon board candidates which can be voted absentee.

The 2020 corona virus pandemic has made this a challenge.

· The April 2020 quarterly business conference was not held at all due to government stay-at-home orders.

 $\cdot$  The July 2020 quarterly business conference was held, but with only 41 members in attendance, the required quorum of 50 was not met. Thus, voting on key items from Enlistment, Properties, and Finance committees could not occur.

With pending and upcoming votes on issues regarding Properties, Enlistment, Finance, 2021 Budget approval, and others approaching, the College Park Deacon board determined that it was necessary to institute an emergency, temporary policy that would allow for remote business conference attendance and remote voting during the course of this 2020/2021 pandemic. This emergency, temporary policy would not constitute a permanent change to the constitution; rather would allow College Park to continue to conduct business during the pandemic, while many members are not comfortable gathering in groups. Once the pandemic ends, then normal constitutional requirements for in-person business conferences would resume.

The key points of this temporary, emergency provision follow:

 $\cdot$  Use the Zoom online platform to allow members to attend business conferences remotely from home through their personal laptops, tablets, or smartphones.

· Remote attendance through Zoom would count a member as attending and count toward the required quorum.

• Remote attendees would be allowed to vote on matters before the church through the Zoom platform. The deacons would establish a process through which online votes would be collected and counted.

 $\cdot$  All business conferences during this period would be held only in Smith Hall as this is the only space in the church that currently comes close to being able to support this remote online effort. However, upgrades to the hardware in Smith Hall would be required, in the amount of approximately \$3,500.

A special called business meeting will be held in Smith Hall on Wednesday night, September 16, at 7:00 pm for the congregation to vote on this temporary, emergency provision that would over-ride the constitutional requirement for an in-person quorum and in-person voting during this pandemic. In the event a quorum of 50 or more members are not present Wednesday meeting, the special called business meeting will move to Sunday morning, September 20, in both services, for this vote.
